

Continental Tire x Elite Club National League (ECNL) Sweepstakes

OFFICIAL RULES

NO PURCHASE, PAYMENT, PROOF OF PURCHASE OR ENTRY FEE OF ANY KIND IS NECESSARY TO ENTER, AND ENTRY TO THE SWEEPSTAKES IS FREE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES TO WIN. ENTRY OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES AND DISTRICT OF COLUMBIA WHO ARE 18 YEARS OF AGE OR OLDER ON DATE OF ENTRY (19 YEARS OLD IF A RESIDENT OF AL OR NE; 21 YEARS OLD IF A RESIDENT OF MS). 1) SWEEPSTAKES TIMING: The Continental Tire x ECNL Sweepstakes (the "Sweepstakes") starts 6/1/2024 at 7:00 AM Eastern Standard Time (EST) and ends 6/30/2024 at 11:59:59 PM EST (the "Sweepstakes Entry Period"). Sponsor's computer is the official timekeeper for this Sweepstakes.

2) ELIGIBILITY: This Sweepstakes is offered and open only to persons legally residing in the United States or District of Columbia who are at least eighteen (18) years of age on the date of entry in this Sweepstakes. Officers, directors and employees of Continental Tire of the Americas, LLC ("Sponsor") and its parent, subsidiary and affiliated companies, distributors, advertising, promotional and judging agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes (collectively, the "Sweepstakes Entities") and the immediate family members (parent, child, sibling, IRS dependent and spouse of each) of and/or persons living in the same household as such individuals (whether related or not) are not eligible to participate. This Sweepstakes is void in Florida, New York, Rhode Island, Puerto Rico, all other U.S. territories and possessions, and wherever else prohibited by law. U.S. law governs this Sweepstakes.

3) HOW TO ENTER:

Microsite Method: During the Sweepstakes Entry Period, participants may enter directly through the domain <https://continentaltire.votigo.com/ECNLSweepstakes>. Once a participant submits his/her information, the participant is entered in to win the overall Grand Prize and/or a receive a Basic Prize (collectively "Prizes"). All terms and conditions of Votigo apply.

By submitting information on the microsite, entrant agrees to the terms of use and privacy notice found at said website. Normal time, toll, connection and usage rates, if any, charged by your Internet service provider may apply. By successfully transmitting your entry as directed, you will receive one (1) entry into the Sweepstakes. If an entrant uses multiple accounts or usernames for any of the three entry methods noted below to submit more than one entry during the Sweepstakes Period, he/she will be disqualified.

Proof of transmission (such as a “confirming” message) of the Sweepstakes entry does not constitute proof of submission/delivery. All entries must be submitted according to these Official Rules no later than 11:59:59 PM EST on the final day of the contest, 6/30/2024. By entering in the Sweepstakes, all entrants agree to abide by these Official Rules, which are final and binding on all matters pertaining to this Sweepstakes. Each entry registration submitted must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified.

4) EVENT DRAWING: There will be a random drawing that will occur on the Event date listed below (“Event Drawing”). The random drawing will be conducted by Votigo, Inc., the contesting platform utilized, whose decisions on all matters related to the Sweepstakes drawing shall be final and binding. The Sweepstakes Grand Prize Winner will be selected by random drawing from all eligible entries received. To be eligible to win, the Sweepstakes entry must be successfully submitted before 11:59:59 PM EST on the date of the applicable Event listed below. Event date is scheduled to be as follows, subject to change:

5) NOTIFICATION OF WINNERS: Potential Basic Prize Winners and Grand Prize Winner (collectively “Winner(s)”) are subject to eligibility verification and compliance with these Official
